 - Hand feed on grass, fields or improved pasture, sufficient quantities to maintain growth and health of calf.
 - Free choice salt and minerals at all times.
 - Adequate and clean water supply.
- IV. Required health records:
- Must complete, sign and send to Jordan Cattle Auction this sale certification form
- V. Required processing:
- Ranch raised or ownership for a minimum of 90 days.
 - All bull calves are to be castrated prior to or at weaning and healed by sale day.
 - Dehorn or tip horns prior to or at weaning.
 - Administration of vaccine
 1. Use the neck area for intramuscular injections
 2. Use subcutaneous injection if labeled on product
 3. Follow label directions and handle vaccines properly.
 - Arrive by Tuesday prior to the Thursday sale.
